A stylish 4 bedroom period house, with an attached forge building full of character and separate outbuilding. Situated on the edge of the village Hopton.

Directions: From Diss head west along the A1066 towards Thetford. At Garboldisham turn left at the crossroads, continue out of the village. Proceed into the village of Hopton. Past the shop on the left and The Old Smithy is a little further down the hill on the right.

The Property: As the name suggests, once the village forge, the smithy building still remains largely untouched with its two forge fireplaces. The house is full of character and well presented throughout, four bedrooms one of which has an ensuite shower.

Outside: Set quite central to its 0.72ac plot. To the front is a shingle drive for several cars. The rear garden offers attractive views over a rolling countryside landscape.

Services: Mains water and electricity are connected. Private drainage. Oil fired boiler providing heating to radiators. Bottled gas supply for the hob.

Terms of the Tenancy: The property will be let on an Assured Shorthold Tenancy for an initial fixed term of a minimum of 6 months.

Rent: The rent, exclusive of all other outgoings and Council Tax will be £1500 per calendar month payable monthly in advance by standing order.

Tenancy Deposit: A Tenancy Deposit of five weeks rent will be payable to the Agent on signing the tenancy agreement. This will be held in a government approved deposit scheme by either the Landlord or the Agent.

Tenancy Agreement: A draft copy of the tenancy agreement will be available for inspection at the Agent's offices.

Council Tax Band: E

Viewing: Strictly by appointment with the Agents.

Applications: Applicants, once accepted in principle by the Landlord must pay a Holding Deposit of 1 week's rent £346 and complete an online application and undergo a full reference and credit check.
